Guidelines Governing Call of Vessels at Private Ports under the

Jurisdiction of PPA Port Management Office SOCSARGEN and

the Payment of Applicable Charges Thereof

1. Authority

1.1. Presidential Decree No. 857

2. Objectives

- 2.1. To enhance efficient monitoring of vessel and cargo movement at private ports particularly on third party cargoes.
- 2.2. To ensure all revenues from port fees accruing from vessels and cargoes serviced in PPA officially registered private ports are properly collected.
- 2.3. To establish the process flow and specify the responsibilities in the diversion of vessels from the Baseport to any registered private port under the jurisdiction of PMO Socsargen.

3. Scope and Coverage

All vessels engaged in foreign or coast wise trade whose particulars warrant berthing or diversion to officially registered private ports.

4. General Guidelines

- 4.1. Vessels engaged in foreign or coast-wise trade may be allowed to call at officially registered private ports under the jurisdiction PMO Socsargen on the basis of the following circumstances¹:
 - 4.1.1. Where the government port/Makar Baseport cannot accommodate the vessels and/or handle their cargoes due to (1) pier congestion or (2) because of physical limitations e.g. draft limitation or (3) inadequacy of government facilities or (4) lack of cargo handling equipment or (5) other related causes;
 - 4.1.2. Where the private ports are duly registered and/or authorized by PPA to handle specific cargoes belonging or consigned to the owners or operators or said ports and particular firms which cargoes require particular type of cargo-handling equipment not available in government ports.
 - 4.1.3. Where the private ports are duly authorized by PPA to handle any cargoes, regardless of whether they are owned by the private port owners/operators or solely belonging to third parties, thus making public the service operations of said ports.

5. Specific Guidelines

Berthing Permit/ Permission to Proceed to Private Port

- 5.1. Any vessel engaged in foreign or coast wise trade carrying cargoes under the situations covered enumerated in Item 4.1 shall be <u>required to secure the prior permission of PMO SOCSARGEN before proceeding to the private port to load/unload cargoes².</u>
 - 5.1.1. Vessel must comply with the submission of Notice of Arrival (NOA) /Application for Berth Anchorage³.
 - 5.1.2. For vessel falling under situation 4.1.2 and 4.1.3 above, the Harbor Operations Officer-On Duty stamps the NOA with "PERMITTED TO BERTH AT PRIVATE PORT PER 4PPA MO 13-82" and furnishes the duly stamped copy of the NOA to the vessel/shipping agent/representative.
 - 5.1.3. For vessels falling under situation 4.1.1 above, upon receipt of the NOA:
 - 5.1.3.1. The Harbor Master or the Terminal Supervisor, as applicable, shall certify/attest to the particular/s enumerated under Item 4.1.1 applicable to the concerned vessel which warrant its diversion to an officially registered private port.

- 5.1.3.2. The Harbor Master accomplishes the Berthing Permit/Diversion to Private Port (Annex A), and electronically submits the same to the PSD Manager duly supported with the following:
 - 5.1.3.2.1. Duly accomplished Notice of Arrival;
 - 5.1.3.2.2. Certification from the Harbor Master or the Terminal Supervisor.
- 5.1.4. The PSD Manager recommends approval to the Port Manager.
- 5.1.5. The Port Manager grants permission to the concerned vessel by approving the Berthing Permit.
- 5.1.6. The Harbor Master or Harbor Operations Officer On-Duty issues the duly approved Berthing Permit to the concerned vessel.

6. Payment of Port Charges / Vessel Departure

- 6.1. Payments for wharfage, dockage and usage fees accruing to cargoes or vessels serviced in PPA officially registered private ports shall be equivalent to only 50% of those serviced in government ports.
- 6.2. The privilege on reduced fees given to private ports with permanent but expired Certificate of Registration shall be extended for a maximum period of 6 months to allow the private owner sufficient time to complete the required documents, provided an application for the renewal of the foreshore lease and PPA permit to operate shall be made prior to lease and operating expiration.
- 6.3. Any vessel permitted to berth at any private port under the jurisdiction of PMO SOCSARGEN shall not be granted departure clearance unless all port charges are paid prior to actual departure as evidenced by PPA official receipts.

7. Reportorial Requirements

7.1. The Berthing Status of all vessels calling in private ports shall be incorporated in the Daily Berthing Order being prepared by the Marine Section.

This Order takes effect immediately.
